Adoption Process & Terms

- **Application Approval:** Document submissions and deposits are only accepted after a full interview has been successfully conducted and you are approved to join the family.
- **Price Guarantee:** The quoted price of your kitten is locked and valid for exactly one year from the date this agreement is signed.

Terms of Care & Health Guarantee

- **Initial Veterinary Exam Requirement:** The Purchaser must have the kitten examined by a licensed veterinarian within 72 hours of receipt. Failure to complete this medical check within the 72-hour window constitutes a breach of contract, voids the Health Guarantee, and releases the Breeder from all financial responsibilities.
- **Observed Health:** The Purchaser acknowledges satisfaction with the visible health status of the kitten at the exact time of transfer.
- **Strict Indoor-Only Policy:** Ragdolls have a highly trusting nature and lack the ability to defend themselves against outdoor hazards, attacks, or theft. The kitten must live strictly indoors as a pet. Outdoor transit is permitted only inside a secure travel carrier for necessary medical or transport needs (never on a leash, in a stroller, or loose outdoors).

- **No Declawing:** The Purchaser explicitly promises never to have the kitten declawed for any reason.
- **Registration Documents:** The kitten is officially registered in the Breeder's name. TICA registration documents will be forwarded to the Purchaser as soon as they are received from the registry.
- **First Refusal & Rehoming Restrictions:** If the Purchaser can no longer care for or wishes to rehome the kitten at any stage of its life, the Breeder maintains right of first refusal. The kitten shall never be sold, willed, given away, or donated to any shelter, pet shop, cat rescue, research lab, or unapproved third party without the Breeder's prior express written consent.
- **Breach and Repossession:** Any breach of this agreement, neglect, maltreatment, or failure to secure proper medical care requires the Purchaser to immediately and unconditionally surrender the kitten to the Breeder without financial compensation. The Purchaser covers all travel and legal fees incurred if repossession occurs.
- **Liability Limit:** Ongoing medical care and future costs are the sole responsibility of the Purchaser. Breeder liability is restricted strictly to a replacement kitten according to the health guarantee; no cash refunds are issued. Show potential or competition success is not guaranteed.
